16 (3) “Agreement” means an agreement between a provider and an individual for the

17 performance of debt-management services.

18 (4) “Bank” means a financial institution, including a commercial bank, savings bank,

19 savings and loan association, credit union, and trust company, engaged in the business of

20 banking, chartered under federal or state law, and regulated by a federal or state banking

21 regulatory authority.

22 (5) “Business address” means the physical location of a business, including the name

23 and number of a street.

1 (6) (A) “Certified counselor” means an individual certified by a training program or
2 certifying organization, approved by the administrator, that authenticates the competence of
3 individuals providing education and assistance to other individuals in connection with debt-
4 management services in which an agreement contemplates that creditors will reduce finance
5 charges or fees for late payment, default, or delinquency.

6 (B) “Certified debt specialist” means an individual certified by a training
7 program or certifying organization, approved by the administrator, that authenticates the
8 competence of individuals providing education and assistance to other individuals in connection
9 with debt-management services in which an agreement contemplates that creditors will settle
10 debts for less than the full principal amount of debt owed.

11 (7) “Concessions” means assent to repayment of a debt on terms more favorable to an
12 individual than the terms of the contract between the individual and a creditor.

13 (8) “Day” means calendar day.

14 (9) “Debt-management services” means services as an intermediary between an
15 individual and one or more creditors of the individual for the purpose of obtaining concessions,
16 but does not include:

17 (A) legal services provided in an attorney-client relationship by an attorney
18 licensed or otherwise authorized to practice law in this state;

19 (B) accounting services provided in an accountant-client relationship by a
20 certified public accountant licensed to provide accounting services in this state; or

21 (C) financial-planning services provided in a financial planner-client relationship
22 by a member of a financial-planning profession whose members the administrator, by rule,
23 determines are

- (i) licensed by this state;
- (ii) subject to a disciplinary mechanism;
- (iii) subject to a code of professional responsibility; and
- (iv) subject to a continuing-education requirement.

(10) “Entity” means a person other than an individual.

(11) “Good faith” means honesty in fact and the observance of reasonable standards of fair dealing.

(12) “Lead generator” means a person who supplies a provider with the names of potential customers, directs communications of an individual to a provider, or otherwise channels customers to a provider.

~~(12)~~(13) “Person” means an individual, corporation, business trust, estate, trust, partnership, limited liability company, association, joint venture, or any other legal or commercial entity. The term does not include a public corporation, government, or governmental subdivision, agency, or instrumentality.

~~(13)~~(14) “Plan” means a program or strategy in which a provider furnishes debt-management services to an individual and which includes a schedule of payments to be made by or on behalf of the individual and used to pay debts owed by the individual.

~~(14)~~(15) “Principal amount of the debt” means the amount of a debt at the time of an agreement.

~~(15)~~(16) “Provider” means a person that provides, offers to provide, or agrees to provide debt-management services directly or through others.

~~(16)~~(17) “Record” means information that is inscribed on a tangible medium or that is stored in an electronic or other medium and is retrievable in perceivable form.

1 | ~~(17)~~(18) “Settlement fee” means a charge imposed on or paid by an individual in
2 | connection with a creditor’s assent to accept in full satisfaction of a debt an amount less than the
3 | principal amount of the debt.

4 | ~~(18)~~(19) “Sign” means, with present intent to authenticate or adopt a record:

5 | (A) to execute or adopt a tangible symbol; or

6 | (B) to attach to or logically associate with the record an electronic sound, symbol, or
7 | process.

8 | ~~(19)~~(20) “State” means a state of the United States, the District of Columbia, Puerto
9 | Rico, the United States Virgin Islands, or any territory or insular possession subject to the
10 | jurisdiction of the United States.

1 **SECTION 3. EXEMPT AGREEMENTS AND PERSONS.**

2 (a) This [act] does not apply to an agreement with an individual who the provider has no
3 reason to know resides in this state at the time of the agreement.

4 (b) This [act] does not apply to a provider to the extent that the provider:

5 (1) provides or agrees to provide debt-management, educational, or counseling
6 services to an individual who the provider has no reason to know resides in this state at the time
7 the provider agrees to provide the services; or

8 (2) receives no compensation for debt-management services from or on behalf of
9 the individuals to whom it provides the services or from their creditors.

10 (c) This [act] does not apply to the following persons or their employees when the
11 person or the employee is engaged in the regular course of the person's business or profession:

12 (1) a judicial officer, a person acting under an order of a court or an
13 administrative agency, or an assignee for the benefit of creditors;

14 (2) a bank;

15 (3) an affiliate, as defined in Section 2(2)(B)(i), of a bank if the affiliate is
16 regulated by a federal or state banking regulatory authority; or

17 (4) a title insurer, escrow company, or other person that provides bill-paying
18 services if the provision of debt-management services is incidental to the bill-paying services.

19 | **SECTION 4. REGISTRATION ~~[AND NOT FOR PROFIT STATUS]~~ REQUIRED.**

20 (a) Except as otherwise provided in subsection (b), a provider may not provide debt-
21 management services to an individual who it reasonably should know resides in this state at the
22 time it agrees to provide the services, unless the provider is registered under this [act].

23 (b) If a provider is registered under this [act], subsection (a) does not apply to an

1 employee or agent of the provider.

2 (c) The administrator shall maintain and publicize a list of the names of all registered
3 providers.

3 **SECTION 5. APPLICATION FOR REGISTRATION: FORM, FEE, AND**
4 **ACCOMPANYING DOCUMENTS.**

5 (a) An application for registration as a provider must be in a form prescribed by the
6 administrator.

7 (b) Subject to adjustment of dollar amounts pursuant to Section 32(f), an application for
8 registration as a provider must be accompanied by:

9 (1) the fee established by the administrator;

10 (2) the bond required by Section 13;

11 | (3) identification of all trust accounts ~~required by Section 22~~ and an irrevocable
12 consent authorizing the administrator to review and examine the trust accounts;

13 (4) evidence of insurance in the amount of \$250,000:

14 (A) against the risks of dishonesty, fraud, theft, and other misconduct on
15 the part of the applicant or a director, employee, or agent of the applicant;

16 (B) issued by an insurance company authorized to do business in this state
17 and rated at least A or equivalent by a nationally recognized rating organization approved by the
18 administrator;

19 (C) with a deductible not exceeding \$5,000;

20 (D) payable for the benefit of the applicant, this state, and individuals
21 who are residents of this state, as their interests may appear; and

22 (E) not subject to cancellation by the applicant or the insurer until 60 days
23 after written notice has been given to the administrator;

32 **INFORMATION.** An application for registration must be signed under [oath] [penalty of false
33 statement] and include:

34 (1) the applicant’s name, principal business address and telephone number, and all other
35 business addresses in this state, electronic-mail addresses, and Internet website addresses;

36 (2) all names under which the applicant conducts business;

37 (3) the address of each location in this state at which the applicant will provide debt-

1 management services or a statement that the applicant will have no such location;

2 (4) the name and home address of each officer and director of the applicant and each
3 person that owns at least 10 percent of the applicant;

4 (5) identification of every jurisdiction in which, during the five years immediately
5 preceding the application:

6 (A) the applicant or any of its officers or directors has been licensed or registered
7 to provide debt-management services; or

8 (B) individuals have resided when they received debt-management services from
9 the applicant;

10 (6) a statement describing, to the extent it is known or should be known by the applicant,
11 any material civil or criminal judgment or litigation and any material administrative or
12 enforcement action by a governmental agency in any jurisdiction against the applicant, any of its
13 officers, directors, owners, or agents, or any person who is authorized to have access to ~~the a~~
14 trust account ~~required by Section 22~~;

15 (7) the applicant's financial statements, audited by an accountant licensed to conduct
16 audits, for each of the two years immediately preceding the application or, if it has not been in
17 operation for the two years preceding the application, for the period of its existence;

18 (8) evidence of accreditation by an independent accrediting organization approved by the
19 administrator;

20 (9) evidence that, within 12 months after initial employment, each of the applicant's
21 counselors becomes certified as a certified counselor or certified debt specialist;

22 (10) a description of the three most commonly used educational programs that the
23 applicant provides or intends to provide to individuals who reside in this state and a copy of any

1 materials used or to be used in those programs;

2 (11) a description of the applicant's financial analysis and initial budget plan, including
3 any form or electronic model, used to evaluate the financial condition of individuals;

8 (14) at the applicant's expense, the results of a criminal-records check, including
9 fingerprints, conducted within the immediately preceding 12 months, covering every officer of
10 the applicant and every employee or agent of the applicant who is authorized to have access to

11 ~~the a trust account required by Section 22;~~

12 (15) the names and addresses of all employers of each director during the 10 years
13 immediately preceding the application;

14 (16) a description of any ownership interest of at least 10 percent by a director, owner, or
15 employee of the applicant in:

16 (A) any affiliate of the applicant; or

17 (B) any entity that provides products or services to the applicant or any
18 individual relating to the applicant's debt-management services;

19 (17) a statement of the amount of compensation of the applicant's five most highly
20 compensated employees for each of the three years immediately preceding the application or, if
21 it has not been in operation for the three years preceding the application, for the period of its
22 existence;

23 (18) the identity of each director who is an affiliate, as defined in Section 2(2)(A) or

1 (B)(i), (ii), (iv), (v), (vi), or (vii), of the applicant; and

2 (19) any other information that the administrator reasonably requires to perform the
3 administrator's duties under Section 9.

4 *Legislative Note: In the introductory language to this section, the state must determine whether*
5 *to require the application to be made "under oath" or "under penalty of false statement."*
6 *Similar choices are necessary in Sections 11 and 12.*

8 **SECTION 7. APPLICATION FOR REGISTRATION: OBLIGATION TO**

9 **UPDATE INFORMATION.** An applicant or registered provider shall notify the administrator
10 within 10 days after a change in the information specified in Section 5(b)(4) or (6) or 6(1), (3),
11 (6), (12), or (13).

12 **SECTION 8. APPLICATION FOR REGISTRATION: PUBLIC INFORMATION.**

13 Except for the information required by Section 6 (7), (14), and (17) and the addresses required
14 by Section 6(4), the administrator shall make the information in an application for registration as
15 a provider available to the public.

16 **SECTION 9. CERTIFICATE OF REGISTRATION: ISSUANCE OR DENIAL.**

17 (a) Except as otherwise provided in subsections (c) and (d), the administrator shall issue
18 a certificate of registration as a provider to a person that complies with Sections 5 and 6.

19 (b) If an applicant has otherwise complied with Sections 5 and 6, including a timely
20 effort to obtain the information required by Section 6(14) but the information has not been
21 received, the administrator may issue a temporary certificate of registration. The temporary
22 certificate shall expire no later than 180 days after issuance.

23 (c) The administrator may deny registration if:

24 (1) the application contains information that is materially erroneous or

1 incomplete;

2 (2) an officer, director, or owner of the applicant has been convicted of a crime,
3 or suffered a civil judgment, involving dishonesty or the violation of state or federal securities
4 laws;

5 (3) the applicant or any of its officers, directors, or owners has defaulted in the
6 payment of money collected for others; or

7 (4) the administrator finds that the financial responsibility, experience, character,
8 or general fitness of the applicant or its owners, directors, employees, or agents does not warrant
9 belief that the business will be operated in compliance with this [act].

10 (d) The administrator shall deny registration if, with respect to an applicant that is
11 organized as a not-for-profit entity or has obtained tax-exempt status under the Internal Revenue
12 Code, 26 U.S.C. Section 501 [, as amended], the applicant's board of directors is not
13 independent of the applicant's employees and agents.

14 (e) Subject to adjustment of the dollar amount pursuant to Section 32(f), a board of
15 directors is not independent for purposes of subsection(d) if more than one-fourth of its
16 members:

17 (1) are affiliates of the applicant, as defined in Section 2(2)(A) or (B)(i), (ii), (iv),
18 (v), (vi), or (vii); or

19 (2) after the date 10 years before first becoming a director of the applicant, were
20 employed by or directors of a person that received from the applicant more than \$25,000 in
21 either the current year or the preceding year.

7 | **SECTION 10. CERTIFICATE OF REGISTRATION: TIMING.**

8 | (a) The administrator shall approve or deny an initial registration as a provider within
9 | 120 days after an application is filed. In connection with a request pursuant to Section 6(19) for
10 | additional information, the administrator may extend the 120-day period for not more than 60
11 | days. Within seven days after denying an application, the administrator, in a record, shall inform
12 | the applicant of the reasons for the denial.

13 | (b) If the administrator denies an application for registration as a provider or does not act
14 | on an application within the time prescribed in subsection (a), the applicant may appeal and
15 | request a hearing pursuant to [insert the citation to the appropriate section of the administrative
16 | procedure act or other statute governing administrative procedure].

17 | (c) Subject to Sections 11(d) and 34, a registration as a provider is valid for one year.

18 | **SECTION 11. RENEWAL OF REGISTRATION.**

19 | (a) A provider must obtain a renewal of its registration annually.

20 | (b) An application for renewal of registration as a provider must be in a form prescribed
21 | by the administrator, signed under [oath] [penalty of false statement], and:

22 | (1) be filed no fewer than 30 and no more than 60 days before the registration
23 | expires;

24 | (2) be accompanied by the fee established by the administrator and the bond
25 | required by Section 13;

1 (3) contain the matter required for initial registration as a provider by Section
2 6(8) and (9) and a financial statement, audited by an accountant licensed to conduct audits, for
3 the applicant's fiscal year immediately preceding the application;

4 (4) disclose any changes in the information contained in the applicant's
5 application for registration or its immediately previous application for renewal, as applicable. If
6 an application is otherwise complete and the applicant has made a timely effort to obtain the
7 information required by Section 6(14) but the information has not been received, the
8 administrator may issue a temporary renewal of registration. The temporary renewal shall expire
9 no later than 180 days after issuance;

10 (5) supply evidence of insurance in an amount equal to the larger of \$250,000 or
11 the highest daily balance in ~~the each~~ trust account ~~required by Section 22~~ during the six-month
12 period immediately preceding the application:

13 (A) against risks of dishonesty, fraud, theft, and other misconduct on the
14 part of the applicant or a director, employee, or agent of the applicant;

15 (B) issued by an insurance company authorized to do business in this state
16 and rated at least A or equivalent by a nationally recognized rating organization approved by the
17 administrator;

18 (C) with a deductible not exceeding \$5,000;

19 (D) payable for the benefit of the applicant, this state, and individuals who
20 are residents of this state, as their interests may appear; and

21 (E) not subject to cancellation by the applicant or the insurer until 60 days
22 after written notice has been given to the administrator;

23 (6) disclose the total amount of money deposited in trust accounts or received by

1 the applicant pursuant to plans during the preceding 12 months from or on behalf of individuals
2 who reside in this state and the total amount of money distributed to creditors of those
3 individuals during that period;

4 (7) disclose, to the best of the applicant's knowledge, the gross amount of money
5 accumulated during the preceding 12 months pursuant to plans by or on behalf of individuals
6 who reside in this state and with whom the applicant has agreements; and

7 (8) provide any other information that the administrator reasonably requires to
8 perform the administrator's duties under this section.

9 (c) Except for the information required by Section 6(7), (14), and (17) and the addresses
10 required by Section 6(4), the administrator shall make the information in an application for
11 renewal of registration as a provider available to the public.

12 (d) If a registered provider files a timely and complete application for renewal of
13 registration, the registration remains effective until the administrator, in a record, notifies the
14 applicant of a denial and states the reasons for the denial.

15 (e) If the administrator denies an application for renewal of registration as a provider,
16 the applicant, within 30 days after receiving notice of the denial, may appeal and request a
17 hearing pursuant to [insert the citation to the appropriate section of the Administrative Procedure
18 Act or other statute governing administrative procedure]. Subject to Section 34, while the appeal
19 is pending the applicant shall continue to provide debt-management services to individuals with
20 whom it has agreements. If the denial is affirmed, subject to the administrator's order and
21 Section 34, the applicant shall continue to provide debt-management services to individuals with
22 whom it has agreements until, with the approval of the administrator, it transfers the agreements
23 to another registered provider or returns to the individuals all unexpended money that is under

1 the applicant's control.

8 **SECTION 12. REGISTRATION IN ANOTHER STATE.** If a provider holds a
9 license or certificate of registration in another state authorizing it to provide debt-management
10 services, the provider may submit a copy of that license or certificate and the application for it
11 instead of an application in the form prescribed by Section 5(a), 6, or 11(b). The administrator
12 shall accept the application and the license or certificate from the other state as an application for
13 registration as a provider or for renewal of registration as a provider, as appropriate, in this state
14 if:

15 (1) the application in the other state contains information substantially similar to or more
16 comprehensive than that required in an application submitted in this state;

17 (2) the applicant provides the information required by Section 6(1), (3), (10), (12), and
18 (13); and

19 (3) the applicant, under [oath] [penalty of false statement], certifies that the information
20 contained in the application is current or, to the extent it is not current, supplements the
21 application to make the information current.

22 **Legislative Note:** *In paragraph (3) the state must determine whether to require the certification*
23 *to be made "under oath" or "under penalty of false statement."*

25 **SECTION 13. BOND REQUIRED.**

26 (a) Except as otherwise provided in Section 14, a provider that is required to be
27 registered under this [act] shall file a surety bond with the administrator, which must:

1 (1) be in effect during the period of registration and for two years after the
2 provider ceases providing debt-management services to individuals in this state; and

3 (2) run to this state for the benefit of this state and of individuals who reside in
4 this state when they agree to receive debt-management services from the provider, as their
5 interests may appear.

6 (b) Subject to adjustment of the dollar amount pursuant to Section 32(f), a surety bond
7 filed pursuant to subsection (a) must:

8 (1) be in the amount of \$50,000 or other larger or smaller amount that the
9 administrator determines is warranted by the financial condition and business experience of the
10 provider, the history of the provider in performing debt-management services, the risk to
11 individuals, and any other factor the administrator considers appropriate;

12 (2) be issued by a bonding, surety, or insurance company authorized to do
13 business in this state and rated at least A by a nationally recognized rating organization; and

14 (3) have payment conditioned upon noncompliance of the provider or its agent
15 with this [act].

16 (c) If the principal amount of a surety bond is reduced by payment of a claim or a
17 judgment, the provider shall immediately notify the administrator and, within 30 days after
18 notice by the administrator, file a new or additional surety bond in an amount set by the
19 administrator. The amount of the new or additional bond must be at least the amount of the bond
20 immediately before payment of the claim or judgment. If for any reason a surety terminates a
21 bond, the provider shall immediately file a new surety bond in the amount of \$50,000 or other
22 amount determined pursuant to subsection (b).

23 (d) The administrator or an individual may obtain satisfaction out of the surety bond

1 procured pursuant to this section if:

2 (1) the administrator assesses expenses under Section 32(b)(1), issues a final
3 order under Section 33(a)(2), or recovers a final judgment under Section 33(a)(4) or (5) or (d); or

4 (2) an individual recovers a final judgment pursuant to Section 35(a), (b), or
5 (c)(1), (2), or (4).

6 (e) If claims against a surety bond exceed or are reasonably expected to exceed the
7 amount of the bond, the administrator, on the initiative of the administrator or on petition of the
8 surety, shall, unless the proceeds are adequate to pay all costs, judgments, and claims, distribute
9 the proceeds in the following order:

10 (1) to satisfaction of a final order or judgment under Section 33(a)(2), (4), or (5)
11 or (d);

12 (2) to final judgments recovered by individuals pursuant to Section 35(a), (b), or
13 (c) (1), (2) or (4), pro rata;

14 (3) to claims of individuals established to the satisfaction of the administrator,
15 pro rata; and

16 (4) if a final order or judgment is issued under Section 33(a), to the expenses
17 charged pursuant to Section 32(b)(1).

18 **SECTION 14. BOND REQUIRED: SUBSTITUTE.**

19 (a) Instead of the surety bond required by Section 13, a provider may deliver to the
20 administrator, in the amount required by Section 13(b), and, except as otherwise provided in
21 paragraph (2)(A), payable or available to this state and to individuals who reside in this state
22 when they agree to receive debt-management services from the provider, as their interests may
23 appear, if the provider or its agent does not comply with this [act]:

1 (1) a certificate of insurance

2 (A) issued by an insurance company authorized to do business in this state
3 and rated at least A or equivalent by a nationally recognized rating organization approved by the
4 administrator; and

5 (B) with no deductible, or if the provider supplies a bond in the amount of
6 \$5,000, a deductible not exceeding \$5,000; or

7 (2) with the approval of the administrator:

8 (A) an irrevocable letter of credit, issued or confirmed by a bank
9 approved by the administrator, payable upon presentation of a certificate by the administrator
10 stating that the provider or its agent has not complied with this [act]; or

11 (B) bonds or other obligations of the United States or guaranteed by the
12 United States or bonds or other obligations of this state or a political subdivision of this state, to
13 be deposited and maintained with a bank approved by the administrator for this purpose.

14 (b) If a provider furnishes a substitute pursuant to subsection (a), the provisions of
15 Section 13(a), (c), (d), and (e) apply to the substitute.

16 **SECTION 15. REQUIREMENT OF GOOD FAITH.** A provider shall act in good
17 faith in all matters under this [act].

18 **SECTION 16. CUSTOMER SERVICE.** A provider that is required to be registered
19 under this [act] shall maintain a toll-free communication system, staffed at a level that
20 reasonably permits an individual to speak to a certified counselor, certified debt specialist, or
21 customer-service representative, as appropriate, during ordinary business hours.

22 **SECTION 17. PREREQUISITES FOR PROVIDING DEBT-MANAGEMENT**
23 **SERVICES.**

1 (a) Before providing debt-management services, a registered provider shall give the
2 individual an itemized list of goods and services and the charges for each. The list must be clear
3 and conspicuous, be in a record the individual may keep whether or not the individual assents to
4 an agreement, and describe the goods and services the provider offers:

- 5 (1) free of additional charge if the individual enters into an agreement;
- 6 (2) for a charge if the individual does not enter into an agreement; and
- 7 (3) for a charge if the individual enters into an agreement, using the following
8 terminology, as applicable, and format:

20 (b) A provider may not furnish debt-management services unless the provider, through
21 the services of a certified counselor or certified debt specialist:

- 22 (1) provides the individual with reasonable education about the management of
23 personal finance;

1 (2) has prepared a financial analysis; and

2 (3) if the individual is to make regular, periodic payments:

3 (A) has prepared a plan for the individual;

4 (B) has made a determination, based on the provider's analysis of the
5 information provided by the individual and otherwise available to it, that the plan is suitable for
6 the individual and the individual will be able to meet the payment obligations under the plan; and

7 (C) believes that each creditor of the individual listed as a participating
8 creditor in the plan will accept payment of the individual's debts as provided in the plan.

9 (c) Before an individual assents to an agreement to engage in a plan, a provider shall:

10 (1) provide the individual with a copy of the analysis and plan required by
11 subsection (b) in a record that identifies the provider and that the individual may keep whether or
12 not the individual assents to the agreement;

13 (2) inform the individual of the availability, at the individual's option, of
14 assistance by a toll-free communication system or in person to discuss the financial analysis and
15 plan required by subsection (b); and

16 (3) with respect to all creditors identified by the individual or otherwise known
17 by the provider to be creditors of the individual, provide the individual with a list of:

18 (A) creditors that the provider expects to participate in the plan and grant
19 concessions;

20 (B) creditors that the provider expects to participate in the plan but not
21 grant concessions;

22 (C) creditors that the provider expects not to participate in the plan; and

23 (D) all other creditors.

1 (d) Before an individual assents to an agreement, the provider shall inform the
2 individual, in a record that contains nothing else, that is given separately, and that the individual
3 may keep whether or not the individual assents to the agreement:

4 (1) of the name and business address of the provider;

5 (2) that plans are not suitable for all individuals and the individual may ask the
6 provider about other ways, including bankruptcy, to deal with indebtedness;

7 (3) that establishment of a plan may adversely affect the individual's credit rating
8 or credit scores;

9 (4) that nonpayment of debt may lead creditors to increase finance and other
10 charges or undertake collection activity, including litigation;

11 (5) unless it is not true, that the provider may receive compensation from the
12 creditors of the individual; and

13 (6) that, unless the individual is insolvent, if a creditor settles for less than the
14 full amount of the debt, the plan may result in the creation of taxable income to the individual,
15 even though the individual does not receive any money.

16 (e) If a provider may receive payments from an individual's creditors and the plan
17 contemplates that the individual's creditors will reduce finance charges or fees for late payment,
18 default, or delinquency, the provider may comply with subsection (d) by providing the following
19 disclosure, surrounded by black lines:

7 **SECTION 18. COMMUNICATION BY ELECTRONIC OR OTHER MEANS.**

8 (a) In this section:

9 (1) “Federal act” means the Electronic Signatures in Global and National
10 Commerce Act, 15 U.S.C. Section 7001 et seq.[, as amended].

11 (2) “Consumer” means an individual who seeks or obtains goods or services that
12 are used primarily for personal, family, or household purposes.

13 (b) A provider may satisfy the requirements of Section 17, 19, or 27 by means of the
14 Internet or other electronic means if the provider obtains a consumer’s consent in the manner
15 provided by Section 101(c)(1) of the federal act.

16 (c) The disclosures and materials required by Sections 17, 19, and 27 shall be presented
17 in a form that is capable of being accurately reproduced for later reference.

18 (d) With respect to disclosure by means of an Internet website, the disclosure of the
19 information required by Section 17(d) must appear on one or more screens that:

20 (1) contain no other information; and

21 (2) the individual must see before proceeding to assent to formation of an
22 agreement.

23 (e) At the time of providing the materials and agreement required by Sections 17(c) and

1 (d), 19, and 27, a provider shall inform the individual that upon electronic, telephonic, or written
2 request, it will send the individual a written copy of the materials, and shall comply with a
3 request as provided in subsection (f).

4 (f) If a provider is requested, before the expiration of 90 days after an agreement is
5 completed or terminated, to send a written copy of the materials required by Section 17(c) and
6 (d), 19, or 27, the provider shall send them at no charge within three business days after the
7 request is received, but the provider need not comply with a request more than once per calendar
8 month or if it reasonably believes the request is made for purposes of harassment. If a request is
9 made more than 90 days after an agreement is completed or terminated, the provider shall send
10 within a reasonable time a written copy of the materials requested.

11 (g) A provider that maintains an Internet website shall disclose on the home page of its
12 website or on a page that is clearly and conspicuously connected to the home page by a link that
13 clearly reveals its contents:

- 14 (1) its name and all names under which it does business;
- 15 (2) its principal business address, telephone number, and electronic-mail address,
16 if any; and
- 17 (3) the names of its principal officers.

18 (h) Subject to subsection (i), if a consumer who has consented to electronic
19 communication in the manner provided by Section 101 of the federal act withdraws consent as

23 consumer, within 30 days after receiving the notification, consents to electronic communication

1 in the manner provided in Section 101(c) of the federal act. If the consumer consents, the
2 provider may terminate the agreement only as permitted by Section 19(a)(6)(G).

12 (5) be delivered to the individual immediately upon formation of the agreement;

18 (C) the schedule of payments to be made by or on behalf of the
19 individual, including the amount of each payment, the date on which each payment is due, and
20 an estimate of the date of the final payment;

21 (D) if a plan provides for regular periodic payments to creditors:

22 (i) each creditor of the individual to which payment will be made,
23 the amount owed to each creditor, and any concessions the provider reasonably believes each
24 creditor will offer; and

1 (ii) the schedule of expected payments to each creditor, including
2 the amount of each payment and the date on which it will be made;

3 (E) each creditor that the provider believes will not participate in the plan
4 and to which the provider will not direct payment;

5 (F) how the provider will comply with its obligations under Section 27(a);

6 (G) that the provider may terminate the agreement for good cause, upon
7 return of unexpended money of the individual;

8 (H) that the individual may ~~cancel the agreement as provided in Section~~
9 ~~20~~terminate the agreement at any time, by giving written or electronic notice, in which event the
10 individual will receive all unexpended money in the trust account;

11 (I) that the individual may contact the administrator with any questions or
12 complaints regarding the provider; and

13 (J) the address, telephone number, and Internet address or website of the
14 administrator.

15 (b) For purposes of subsection (a)(5), delivery of an electronic record occurs when it is
16 made available in a format in which the individual may retrieve, save, and print it and the
17 individual is notified that it is available.

18 (c) If the administrator supplies the provider with any information required under
19 subsection (a)(6)(J), the provider may comply with that requirement only by disclosing the
20 information supplied by the administrator.

21 (d) An agreement must provide that:

22 ~~(1) the individual has a right to terminate the agreement at any time, without~~
23 ~~penalty or obligation, by giving the provider written or electronic notice, in which event:~~

1 ~~(A) the provider will refund all unexpended money that the provider or its~~

4 ~~(B) with respect to an agreement that contemplates that creditors will~~
5 ~~settle debts for less than the principal amount of debt, the provider will refund 65 percent of any~~
6 ~~portion of the set up fee that has not been credited against the settlement fee; and~~

1 (1) provide for application of the law of any jurisdiction other than the United
2 States and this state;

3 (2) except as permitted by Section 2 of the Federal Arbitration Act, 9 U.S.C.

5 authorizing predispute arbitration agreements]] contain a provision that modifies or limits
6 otherwise available forums or procedural rights, including the right to trial by jury, that are

5 **SECTION 21. REQUIRED LANGUAGE.** Unless the administrator, by rule, provides
6 otherwise, the disclosures and documents required by this [act] must be in English. If a provider

16 money is not available to creditors of the provider or designee, except an individual from whom

19 (b) A provider may request or require an individual to place money in a trust account.

20 (c) A trust account must be at an insured bank and, unless the individual owns the
21 account, must:

1 (ii) be administered by an entity that is not

2 (A) the provider or

3 (B) an affiliate of the provider; and

7 from the provider in exchange for referrals of business involving debt-management services.

8 (e) Upon termination of an agreement, a person administering a trust account shall,
9 within seven business days of the termination, pay the individual all money received by or on
10 behalf of the individual, other than amounts it has properly disbursed to creditors or the provider.

11 (f) Money in a trust account is not property of the provider or the person administering
12 the account. The money belongs to the individual from whom or on whose behalf it was
13 deposited and is not available to creditors of the person administering the account or creditors of
14 the provider.

16 (1) maintain separate records of account for each individual to whom the
17 provider is furnishing debt-management services;

11 ~~(e)~~(i) A trust account must at all times have a cash balance equal to the sum of the
12 balances of each individual's account.

13 ~~(f) If a provider has established a trust account pursuant to subsection (a), the provider~~

14 (j) A person administering a trust account shall reconcile the trust account at least once a
15 month. The reconciliation must compare the cash balance in the trust account with the sum of the
16 balances in each individual's account. If the provider or its designee has more than one trust
17 account, each trust account must be individually reconciled.

19 subsection and Section 28(d). The administrator may authorize a provider to charge a fee based
20 on the nature and extent of the educational or counseling services furnished by the provider.

21 (d) Subject to adjustment of dollar amounts pursuant to Section 32(f), the following rules
22 apply:

23 (1) Subject to paragraph (2), if an individual assents to a plan that contemplates

1 that creditors will reduce finance charges or fees for late payment, default, or delinquency, the
2 provider may charge:

3 ~~(A) a fee not exceeding \$50 for consultation, obtaining a credit report,
4 setting up an account, and the like; and~~

14 ~~(2) A provider may not request or receive any compensation from or on behalf of

18 ~~(B) the individual has made a payment toward satisfying the modified
19 terms of the debt.~~

20 ~~(3) Subject to subsection (d)(1), if an individual assents to a plan that
21 contemplates that creditors will reduce finance charges or fees for late payment, default, or
22 delinquency, the provider may receive compensation in the form of a monthly service fee, not to
23 exceed \$10 times the number of creditors remaining in a plan at the time the fee is assessed, but~~

1 not more than \$50 in any month.

2 (4) Except as otherwise provided in subsection (c), if an agreement contemplates
3 that creditors will settle an individual's debts for less than the principal amount of the debt:

14 **SECTION 24. VOLUNTARY CONTRIBUTIONS.** A provider may not solicit a
15 voluntary contribution from an individual or an affiliate of the individual for any service
16 provided to the individual. A provider may accept voluntary contributions from an individual
17 but, until 30 days after completion or termination of a plan, the aggregate amount of money
18 received from or on behalf of the individual may not exceed the total amount the provider may
19 charge the individual under Section 23.

20 **SECTION 25. VOIDABLE AGREEMENTS.**

21 (a) If a provider imposes a fee or other charge or receives money or other payments not
22 authorized by Section 23 or 24, the individual may void the agreement and recover as provided
23 in Section 35.

1 (b) If a provider is not registered as required by this [act] when an individual assents to
2 an agreement, the agreement is voidable by the individual.

3 (c) If an individual voids an agreement under subsection (b), the provider does not have
4 a claim against the individual for breach of contract or for restitution.

5 **SECTION 26. ~~[RESERVED] TERMINATION OF AGREEMENTS.~~**

6 ~~(a) If an individual who has entered into an agreement fails for 60 days to make~~

13 **SECTION 27. PERIODIC REPORTS AND RETENTION OF RECORDS.**

14 (a) A provider shall provide the accounting required by subsection (b):

15 (1) upon cancellation or termination of an agreement; and

16 (2) before cancellation or termination of any agreement:

17 (A) at least once each month; and

18 (B) within five business days after a request by an individual, but the
19 provider need not comply with more than one request in any calendar month.

20 (b) A provider, in a record, shall provide each individual for whom it has established a
21 plan an accounting of the following information:

22 (1) the amount of money received from the individual since the last report;

23 (2) the amounts and dates of disbursement made on the individual's behalf, or by

1 the individual upon the direction of the provider, since the last report to each creditor listed in
2 the plan;

3 (3) the amounts deducted from the amount received from the individual;

4 (4) the amount held in reserve; and

5 (5) if, since the last report, a creditor has agreed to accept as payment in full an
6 amount less than the principal amount of the debt owed by the individual:

7 (A) the total amount and terms of the settlement;

8 (B) the amount of the debt when the individual assented to the plan;

9 (C) the amount of the debt when the creditor agreed to the settlement; and

10 (D) the calculation of a settlement fee.

11 (c) A provider shall maintain records for each individual for whom it provides debt-
12 management services for five years after the final payment made by the individual and produce a
13 copy of them to the individual within a reasonable time after a request for them. The provider
14 may use electronic or other means of storage of the records.

15 **SECTION 28. PROHIBITED ACTS AND PRACTICES.**

16 (a) A provider may not, directly or indirectly:

17 (1) misappropriate or misapply money held in trust;

18 (2) settle a debt on behalf of an individual ~~for more than 50 percent of the~~
19 ~~principal amount of the debt owed a creditor~~, unless the individual assents to the settlement after
20 the creditor has assented;

21 (3) take a power of attorney that authorizes it to settle a debt, ~~unless the power of~~
22 ~~attorney expressly limits the provider's authority to settle debts for not more than 50 percent of~~
23 ~~the principal amount of the debt owed a creditor~~;

1 (4) exercise or attempt to exercise a power of attorney after an individual has
2 terminated an agreement;

3 (5) initiate a transfer from an individual's account at a bank or with another
4 person unless the transfer is:

5 (A) a return of money to the individual; or

6 (B) before termination of an agreement, properly authorized by the
7 agreement and this [act], and for:

8 (i) payment to one or more creditors pursuant to an agreement; or

9 (ii) payment of a fee;

10 (6) offer a gift or bonus, premium, reward, or other compensation to an
11 individual for executing an agreement;

12 (7) offer, pay, or give a gift or bonus, premium, reward, or other compensation to
13 a lead generator or other person for referring a prospective customer, if the person making the
14 referral

15 (A) has a financial interest in the outcome of debt-management services
16 provided to the customer, unless neither the provider nor the person making the referral

17 communicates to the prospective customer the identity of the source of the referral, or

18 (B) compensates its employees on the basis of a formula that incorporates
19 the number of individuals the employee refers to the provider;

20 (8) receive a bonus, commission, or other benefit for referring an individual to a
21 person;

22 (9) structure a plan in a manner that would result in a negative amortization of
23 any of an individual's debts, unless a creditor that is owed a negatively amortizing debt agrees to

1 refund or waive the finance charge upon payment of the principal amount of the debt;

2 (10) compensate its employees on the basis of a formula that incorporates the
3 number of individuals the employee induces to enter into agreements;

4 (11) settle a debt or lead an individual to believe that a payment to a creditor is in
5 settlement of a debt to the creditor unless, at the time of settlement, the individual receives a
6 certification by the creditor that the payment is in full settlement of the debt;

7 (12) make a representation that:

8 (A) the provider will furnish money to pay bills or prevent attachments;

9 (B) payment of a certain amount will permit satisfaction of a certain
10 amount or range of indebtedness; or

11 (C) participation in a plan will or may prevent litigation, garnishment,
12 attachment, repossession, foreclosure, eviction, or loss of employment;

13 (13) misrepresent that it is authorized or competent to furnish legal advice or
14 perform legal services;

15 (14) represent in its agreements, disclosures required by this [act],
16 advertisements, or Internet web site that it is

17 (A) a not-for-profit entity unless it is organized and properly operating as
18 a not-for-profit entity under the law of the state in which it was formed; or

19 (B) a tax-exempt entity unless it has received certification of tax-exempt
20 status from the Internal Revenue Service and is properly operating as a not-for-profit entity
21 under the law of the state in which it was formed;

22 (15) take a confession of judgment or power of attorney to confess judgment
23 against an individual; or

1 (16) employ an unfair, unconscionable, or deceptive act or practice, including
2 the knowing omission of any material information.

3 (b) If a provider furnishes debt-management services to an individual, the provider may
4 not, directly or indirectly:

5 (1) purchase a debt or obligation of the individual;

6 (2) receive from or on behalf of the individual:

7 (A) a promissory note or other negotiable instrument other than a check
8 or a demand draft; or

9 (B) a post-dated check or demand draft;

10 (3) lend money or provide credit to the individual, except as a deferral of a
11 settlement fee at no additional expense to the individual;

12 (4) obtain a mortgage or other security interest from any person in connection
13 with the services provided to the individual;

14 (5) except as permitted by federal law, disclose the identity or identifying
15 information of the individual or the identity of the individual's creditors, except to:

16 (A) the administrator, upon proper demand;

17 (B) a creditor of the individual, to the extent necessary to secure the
18 cooperation of the creditor in a plan; or

19 (C) the extent necessary to administer the plan;

20 (6) except as otherwise provided in Section 23(f), provide the individual less than
21 the full benefit of a compromise of a debt arranged by the provider;

22 (7) charge the individual for or provide credit or other insurance, coupons for
23 goods or services, membership in a club, access to computers or the Internet, or any other matter

1 not directly related to debt-management services or educational services concerning personal
2 finance; or

3 (8) furnish legal advice or perform legal services, unless the person furnishing
4 that advice to or performing those services for the individual is licensed to practice law.

5 (c) This [act] does not authorize any person to engage in the practice of law.

6 (d) A provider may not receive a gift or bonus, premium, reward, or other compensation,
7 directly or indirectly, for advising, arranging, or assisting an individual in connection with
8 obtaining, an extension of credit or other service from a lender or service provider, except for
9 educational or counseling services required in connection with a government-sponsored
10 program.

11 (e) Unless a person supplies goods, services, or facilities generally and supplies them to
12 the provider at a cost no greater than the cost the person generally charges to others, a provider
13 may not purchase goods, services, or facilities from the person if an employee or a person that
14 the provider should reasonably know is an affiliate of the provider:

15 (1) owns more than 10 percent of the person; or

16 (2) is an employee or affiliate of the person.

17 **SECTION 29. NOTICE OF LITIGATION.** No later than 30 days after a provider has
18 been served with notice of a civil action for violation of this [act] by or on behalf of an
19 individual who resides in this state at either the time of an agreement or the time the notice is
20 served, the provider shall notify the administrator in a record that it has been sued.

21 **SECTION 30. ADVERTISING.**

22 (a) If the agreements of a provider contemplate that creditors will reduce finance charges
23 or fees for late payment, default, or delinquency and the provider advertises debt-management

1 services, it shall disclose, in an easily comprehensible manner, that using a debt-management
2 plan may make it harder for the individual to obtain credit.

3 (b) If the agreements of a provider contemplate that creditors will settle for less than the
4 full principal amount of debt and the provider advertises debt-management services, it shall
5 disclose, in an easily comprehensible manner, the information specified in Section 17(d)(3) and
6 (4).

7 **SECTION 31. LIABILITY OF PROVIDER FOR THE CONDUCT OF OTHER**
8 **PERSONS; UNLAWFUL CONDUCT BY OTHER PERSONS.**

9 (a) If a provider delegates any of its duties or obligations under an agreement or this
10 [act] to another person, including an independent contractor, the provider is liable for conduct of
11 the person which, if done by the provider, would violate the agreement or this [act].

12 (b) A lead generator or other person that provides services to or for a provider may not
13 engage in an unfair, unconscionable, or deceptive act or practice, including the knowing
14 omission of any material information, in its interactions with an individual whom it has reason to
15 believe is or may become a customer of the provider.

16 **SECTION 32. POWERS OF ADMINISTRATOR.**

17 (a) The administrator may act on its own initiative or in response to complaints and may
18 receive complaints, take action to obtain voluntary compliance with this [act],

19 [refer cases to the [attorney general]], and seek or provide remedies as provided in this
20 [act].

21 (b) The administrator may investigate and examine, in this state or elsewhere, by
22 subpoena or otherwise, the activities, books, accounts, and records of a person that provides or
23 offers to provide debt-management services, or a person to which a provider has delegated its

1 obligations under an agreement or this [act], to determine compliance with this [act]. Information
2 that identifies individuals who have agreements with the provider shall not be disclosed to the
3 public. In connection with the investigation, the administrator may:

4 (1) charge the person the reasonable expenses necessarily incurred to conduct the
5 examination;

6 (2) require or permit a person to file a statement under oath as to all the facts and
7 circumstances of a matter to be investigated; and

8 (3) seek a court order authorizing seizure from a bank at which the person
9 maintains a trust account ~~required by Section 22~~, any or all money, books, records, accounts, and
10 other property of the provider that is in the control of the bank and relates to individuals who
11 reside in this state.

12 (c) The administrator may adopt rules to implement the provisions of this [act] in
13 accordance with [insert the appropriate section of the Administrative Procedure Act or other
14 statute governing administrative procedure].

15 (d) The administrator may enter into cooperative arrangements with any other federal or
16 state agency having authority over providers and may exchange with any of those agencies
17 information about a provider, including information obtained during an examination of the
18 provider.

19 (e) The administrator, by rule, shall establish reasonable fees to be paid by providers for
20 the expense of administering this [act].

21 (f) The administrator, by rule, shall adopt dollar amounts instead of those specified in
22 Sections 2, 5, 9, 13, 23, 33, and 35 to reflect inflation, as measured by the United States Bureau
23 of Labor Statistics Consumer Price Index for All Urban Consumers or, if that index is not

1 available, another index adopted by rule by the administrator. The administrator shall adopt a
2 base year and adjust the dollar amounts, effective on July 1 of each year, if the change in the
3 index from the base year, as of December 31 of the preceding year, is at least 10 percent. The
4 dollar amount must be rounded to the nearest \$100, except that the amounts in Section 23 must
5 be rounded to the nearest dollar.

6 (g) The administrator shall notify registered providers of any change in dollar amounts
7 made pursuant to subsection (f) and make that information available to the public.

8 **Legislative Note:** *If the administrator is the attorney general, the bracketed language in*
9 *subsection (a) (“refer cases to the [attorney general]”) should be deleted. If the administrator is*
10 *not the attorney general, those brackets and the brackets around “attorney general” should be*
11 *deleted. If the state wishes the prosecution to be handled by some other official, the name of that*
12 *official should be substituted for “attorney general.”*

13
14 *In states that do not empower administrative agencies to set fees, replace subsection (e)*
15 *with the desired fees or fee structure.*

17 *The dollar amounts that appear in this Act were selected in August 2005. The state may*
18 *wish to adjust those amounts to reflect changes in the index specified in subsection (f) between*

22 **SECTION 33. ADMINISTRATIVE REMEDIES.**

23 (a) The administrator may enforce this [act] and rules adopted under this [act] by taking
24 one or more of the following actions:

25 | (1) ordering a provider, a lead generator, a person administering a trust account,

26 | or a director, employee, or other agent of a provider to cease and desist from any violations;

27 | (2) ordering a provider, a lead generator, a person administering a trust account,

28 | or a person that has caused a violation to correct the violation, including making restitution of

29 | money or property to a person aggrieved by a violation;

1 (3) subject to adjustment of the dollar amount pursuant to Section 32(f),
2 imposing on a provider or ~~a~~-other person that has violated or caused a violation a civil penalty
3 not exceeding \$10,000 for each violation;

4 (4) prosecuting a civil action to:

5 (A) enforce an order;

6 (B) obtain restitution or an injunction or other equitable relief, or both; or

7 (5) intervening in an action brought under Section 35.

8 (b) Subject to adjustment of the dollar amount pursuant to Section 32(f), if a person
9 violates or knowingly authorizes, directs, or aids in the violation of a final order issued under
10 subsection (a)(1) or (2), the administrator may impose a civil penalty not exceeding \$20,000 for
11 each violation.

12 (c) The administrator may maintain an action to enforce this [act] in any [county].

13 (d) The administrator may recover the reasonable costs of enforcing the [act] under
14 subsections (a) through (c), including attorney's fees based on the hours reasonably expended
15 and the hourly rates for attorneys of comparable experience in the community.

16 (e) In determining the amount of a civil penalty to impose under subsection (a) or (b),
17 the administrator shall consider the seriousness of the violation, the good faith of the violator,
18 any previous violations by the violator, the deleterious effect of the violation on the public, the
19 net worth of the violator, and any other factor the administrator considers relevant to the
20 determination of the civil penalty.

21 **SECTION 34. SUSPENSION, REVOCATION, OR NONRENEWAL OF**
22 **REGISTRATION.**

23 (a) In this section, "insolvent" means:

1 (1) having generally ceased to pay debts in the ordinary course of business other
2 than as a result of good-faith dispute;

3 (2) being unable to pay debts as they become due; or

4 (3) being insolvent within the meaning of the federal bankruptcy law, 11 U.S.C.
5 Section 101 et seq.[, as amended].

6 (b) The administrator may suspend, revoke, or deny renewal of a provider's registration
7 if:

8 (1) a fact or condition exists that, if it had existed when the registrant applied for
9 registration as a provider, would have been a reason for denying registration;

10 (2) the provider has committed a material violation of this [act] or a rule or order
11 of the administrator under this [act];

12 (3) the provider is insolvent;

13 (4) the provider, ~~or~~ an employee or affiliate of the provider, a lead generator, a
14 person administering a trust account, or a person to which the provider has delegated its
15 obligations under an agreement or this [act] has refused to permit the administrator to make an
16 examination authorized by this [act], failed to comply with Section 32(b)(2) within 15 days after
17 request, or made a material misrepresentation or omission in complying with Section 32(b)(2); or

18 (5) the provider has not responded within a reasonable time and in an appropriate
19 manner to communications from the administrator.

20 (c) If a provider does not comply with Section 22~~(h)~~(h)-(j) or if the administrator
21 otherwise finds that the public health or safety or general welfare requires emergency action, the
22 administrator may order a summary suspension of the provider's registration, effective on the
23 date specified in the order.

1 (d) If the administrator suspends, revokes, or denies renewal of the registration of a
2 provider, the administrator may seek a court order authorizing seizure of any or all of the money
3 in a trust account ~~required by Section 22~~, books, records, accounts, and other property of the
4 provider which are located in this state.

5 (e) If the administrator suspends or revokes a provider's registration, the provider may
6 appeal and request a hearing pursuant to [insert the citation to the appropriate section of the
7 administrative procedure act or other statute governing administrative procedure].

8 *Legislative Note: In states in which the constitution does not permit the phrase, "as amended,"*

12 SECTION 35. PRIVATE ENFORCEMENT.

13 (a) If an individual voids an agreement pursuant to Section 25(b), the individual may
14 recover in a civil action all money paid or deposited by or on behalf of the individual pursuant to
15 the agreement, except amounts paid to creditors, in addition to the recovery under subsection
16 (c)(3) and (4).

17 (b) If an individual voids an agreement pursuant to Section 25(a), the individual may
18 recover in a civil action three times the total amount of the fees, charges, money, and payments
19 made by the individual to the provider, in addition to the recovery under subsection (c)(4).

20 (c) Subject to subsection (d), an individual with respect to whom a provider or other
21 person violates this [act] may recover in a civil action from the provider, that person, and any
22 person that caused the violation:

23 (1) compensatory damages for injury, including noneconomic injury, caused by
24 the violation;

1 (2) except as otherwise provided in subsection (d) and subject to adjustment of
2 the dollar amount pursuant to Section 32(f), with respect to a violation of Section 17, 19, 20, 21,
3 22, 23, 24, 27, or 28(a), (b), or (d), the greater of the amount recoverable under paragraph (1) or
4 \$5,000;

5 (3) punitive damages; and

6 (4) reasonable attorney's fees and costs.

7 (d) In a class action, except for a violation of Section 28(a)(5), the minimum damages
8 provided in subsection (c)(2) do not apply.

9 ~~(e) In addition to the remedy available under subsection (c), if a provider violates an~~
10 ~~individual's rights under Section 20, the individual may recover in a civil action all money paid~~
11 ~~or deposited by or on behalf of the individual pursuant to the agreement, except for amounts paid~~
12 ~~to creditors.~~

13 ~~(f)~~(e) A provider is not liable under this section for a violation of this [act] if the provider
14 proves that the violation was not intentional and resulted from a good-faith error notwithstanding
15 the maintenance of procedures reasonably adapted to avoid the error. An error of legal judgment
16 with respect to a provider's obligations under this [act] is not a good-faith error. If, in connection
17 with a violation, the provider has received more money than authorized by an agreement or this
18 [act], the defense provided by this subsection is not available unless the provider refunds the
19 excess within two business days of learning of the violation.

20 ~~(g)~~(f) The administrator shall assist an individual in enforcing a judgment against the
21 surety bond or other security provided under Section 13 or 14.

22 **SECTION 36. VIOLATION OF [UNFAIR OR DECEPTIVE PRACTICES]**

23 **STATUTE.** If an act or practice of a provider violates both this [act] and [insert a reference to

1 the statute dealing with deceptive acts and practices in consumer transactions], an individual may
2 not recover under both for the same act or practice.

6 **SECTION 37. STATUTE OF LIMITATIONS.**

7 (a) An action or proceeding brought pursuant to Section 33(a), (b), or (c) must be
8 commenced within four years after the conduct that is the basis of the administrator's complaint.

9 (b) An action brought pursuant to Section 35 must be commenced within two years
10 after the latest of:

11 (1) the individual's last transmission of money to a provider;

12 (2) the individual's last transmission of money to a creditor at the direction of the
13 provider;

14 (3) the provider's last disbursement to a creditor of the individual;

15 (4) the provider's last accounting to the individual pursuant to Section 27(a);

16 (5) the date on which the individual discovered or reasonably should have
17 discovered the facts giving rise to the individual's claim; or

18 (6) termination of actions or proceedings by the administrator with respect to a
19 violation of the [act].

20 (c) The period prescribed in subsection (b)(5) is tolled during any period during which
21 the provider or, if different, the defendant has materially and willfully misrepresented
22 information required by this [act] to be disclosed to the individual, if the information so
23 misrepresented is material to the establishment of the liability of the defendant under this [act].
24

1 **SECTION 38. UNIFORMITY OF APPLICATION AND CONSTRUCTION.** In
2 applying and construing this Uniform Act, consideration must be given to the need to promote
3 uniformity of the law with respect to its subject matter among states that enact it.

4 **SECTION 39. RELATION TO ELECTRONIC SIGNATURES IN GLOBAL AND**
5 **NATIONAL COMMERCE ACT.** This [act] modifies, limits, and supersedes the federal
6 Electronic Signatures in Global and National Commerce Act (15 U.S.C. Section 7001 et seq.)
7 but does not modify, limit, or supersede Section 101(c) of that act (15 U.S.C. Section 7001(c)) or
8 authorize electronic delivery of any of the notices described in Section 103(b) of that act (15
9 U.S.C. Section 7003(b)).

10 **SECTION 40. TRANSITIONAL PROVISIONS; APPLICATION TO EXISTING**
11 **TRANSACTIONS.** Transactions entered into before this [act] takes effect and the rights,
12 duties, and interests resulting from them may be completed, terminated, or enforced as required
13 or permitted by a law amended, repealed, or modified by this [act] as though the amendment,
14 repeal, or modification had not occurred.

15 **[SECTION 41. SEVERABILITY.** If any provision of this [act] or its application to
16 any person or circumstance is held invalid, the invalidity does not affect other provisions or
17 applications of this [act] that can be given effect without the invalid provision or application, and
18 to this end the provisions of this [act] are severable.]

19 **SECTION 42. REPEAL.** The following laws are repealed:

23 **SECTION 43. EFFECTIVE DATE.** This [act] takes effect 12 months after enactment.
